

## A Wednesday Option for Students Rules and Guidelines:

1. Each student must conduct themselves in a respectful manner towards other students, as well as, all employees and volunteers at Holly Spring Friends Meeting.
2. Each student must be actively involved in the structured activities of the day and must stay with the group at all times.
3. Covid policy:
  - a. Students temperatures will be taken each morning upon arrival. If a student has a temperature over 100, they will not be allowed to stay. Therefore, the parent or guardian must remain until the student has been cleared to stay each Wednesday.
  - b. Masks are welcome but are not required.
  - c. If a parent or guardian wants their student to wear a mask, we will honor that request. Masks are the responsibility of each student and should never be shared with others.
  - d. Hand sanitizers will be available on site and ample opportunities to thoroughly wash hands will be made available.
  - e. Social distancing will be practiced throughout the day.
4. Logging onto pornographic or other inappropriate websites will not be tolerated. Profanity or any other inappropriate behavior will not be allowed.
5. Students must dress modestly and decently. Comfortable shoes are recommended for outside activities.
6. Students are responsible for bringing all of their appropriate school materials/supplies (class assignments, laptop, notebooks, paper, pencils, pens, devices like chargers, headphones, etc.)
7. Students and parents/guardians must respect our "Mission and Statement of Faith" (can be found at [www.hollyspring.org](http://www.hollyspring.org) under "About Us" tab.)
8. Parents must contact the youth pastor if their child will not be attending on any of these Wednesday sessions.

9. Cell Phone Policy: Students will not be allowed to have cell phones on during instructional time. If you need to reach your child, please call the church office (336.879.3136).
